Minutes of the meeting held on Tuesday 26th April 2022. This meeting was held in the Community Centre.

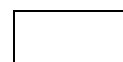

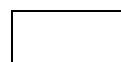

Prior to the start of the meeting the Chairman formally introduced Chris Stirland as the New Clerk and Responsible Financial Officer for Seend Parish Council.

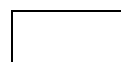

2022/60 Local Councillor's Matters	<p><u>1. WCC Highways</u></p> <p>Cllr Reay explained that WCC has decided to put more emphasis and funding behind what was formally known as the Community Area Transport Group (CATG) and it will be renamed to become the Local Highways & Footpaths Infrastructure Group (LHFIG). The reorganisation is focused on giving local Area Boards and Parish Councils greater control over local priorities for their neighbourhoods. More funding is going to be made available for Area Boards to support this initiative.</p> <p><u>2.Homes for Ukrainian Refugees</u></p> <p>Around 1,500 households registered for the Homes for Ukraine scheme in Wiltshire. Currently 288 homes have been matched with 794 individuals and 307 visas have been issued. Approximately 400 refugees have arrived in Wiltshire.</p> <p>There have been 57 school applications, (40 primary and 17 secondary) with 3 pupils already starting school and more expected to join classes after Easter. WCC are helping the schools prepare for this.</p> <p>Wiltshire is one of the highest unitary authorities in the country to receive visa applications and has drafted in additional support to carry out the necessary checks including accommodation, welfare and suitability checks.</p>	



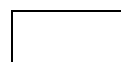

All Councillors who were present at that meeting voted in favour.</p>	
2022/62 Matters Arising Not Already on the Agenda	<p>1. <u>New Councillor Candidate</u></p> <p>The Chairman welcomed Bridget Johnson to the meeting. She is considering becoming a Parish Councillor and if successful will be co-opted onto the Parish Council at the next meeting.</p> <p>2. <u>School Travel Plan and Grounds</u></p> <p>Cllr Reay advised she would be meeting the Group Head for Seend CE Primary School to discuss the School Travel Plan and the continued closure of the School Grounds. The meeting is scheduled to take place 3rd May and she will be accompanied by the Chairman and Phil Springate.</p> <p>3. <u>Asset Register</u></p> <p>The Internal Auditor advised the sum of £1 should be added to the Asset register to cover the value of the Allotment Land. This has been completed.</p> <p>4. <u>2021-2022 Internal Audit</u></p> <p>The Outgoing Clerk (Sue Bond) has worked tirelessly to complete the audit and expedite the Clerk handover. The accounts have been checked by the accountants and found to be correct.</p> <p>Councillors expressed their appreciation for the work Sue has undertaken on behalf of the Parish Council.</p> <p>5. <u>Best Kept Village Competition</u></p> <p>The first round of judging will take place during the first two weeks of May with a second round expected in June.</p> <p>6. <u>The Lye</u></p> <p>Astor have reinstated posts around the parking area to protect the green. 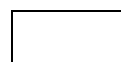

2022/65 Lye Field Pavilion and CLT	<p>1. <u>Lye Field Pavilion and CLT Update</u></p> <p>Steve Vaux (Hon Sec Seend Lye Recreation Field) provided details of ~ £90k refurbishment program for the Pavilion.</p> <ul style="list-style-type: none">Phase1 (£50k) will commence in May focussing on electrical rewiring, installing LED lighting, double glazing and replacing the external doors. The funding for this phase has mainly been provided by the Suez Community Trust.Phase 2 (£43k) will see cavity wall and loft insulation installed along with a new eco-friendly heating system. <p>2. <u>Electric Vehicle Charging Points</u></p> <p>It was noted that as the Pavilion resides on land not owned by WCC, it would not be eligible for a grant under WCC’s EV Charging Infrastructure Strategy (Briefing Note 22-20). Such points could be of significant benefit to local residents who do not have private off-road parking.</p> <p>Cllr Reay was requested to see if WCC could review the strategy to include where the community asset is not owned by WCC but rather other non-profit community institutions. (e.g Village Halls) as the current strategy seems to preclude WCC helping by not considering non council community assets.</p> <p>3. <u>Community Land Trust Housing – Seend Cleeve</u></p> <p>Two access points have been created on the development site and 32 parking spaces will be created in anticipation of works commencing in May. Information boards will be displayed describing the development with contact details for the Contractor and Site Foreman. Whilst Contractor vehicle parking on Seend Cleeve will be discouraged, it cannot be totally prevented. If parishioners observe on-road contractor parking, they are encouraged to contact the site foreman.</p>	Cllr Reay
