

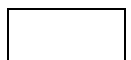
## SEEND PARISH COUNCIL

Minutes of the meeting held on Tuesday 29<sup>th</sup> November 2022. This meeting was held in the Community Centre.

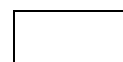

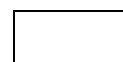

2022/202 Local Councillor’s Matters	<p>Cllr Reay provided the following update on local matters:</p> <p><b>2023 Parliamentary Boundary Review</b> The Parliamentary Boundary Commission has reported its revised proposals following the extensive Spring consultation. It proposes all polling districts which make up the Devizes Area Board (including Devizes Rural West) are included in a new Melksham &amp; Devizes Constituency. A further consultation is running until 5th December – Comments can be made on the Boundary Commission website.</p> <p><b>Devizes Area Board</b> The next Area Board meeting is on 5<sup>th</sup> December. Pam Akerman and John Williams are planning to attend. Dr Richard Sandford-Hill will give an update on the new Integrated Care Centre in Devizes.</p> <p><b>Bollands Hill Road Closure – Initial report from Highways Engineer</b> The damaged highway was initially being investigated as being caused by a possible natural spring, but investigations moved fast and the damage was identified as being caused by a fractured pumped sewer causing a leak damaging the highway.</p> <p>Wessex Water took over the site and were playing catch up with the road closure, and as widely reported, the signage for the closure and diversion were not as the Council had hoped they would have been.</p> <p>Signage is obviously supposed to guide people along our road network, however, there is always an element of free will, and people don’t have to follow our diversions. Highways were informed that all the signage requested had been deployed, so there should have been signage in advance of junctions on the A365 to the north of the closure and A361 to</p>	Pam Akerman/John Williams



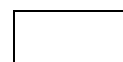

	<p>the south of the closure to advise people of the fact that there was no through route southwards from the A365 or northwards from the A361. This should have deterred people from cutting through Seend Cleeve, but it did not eliminate it.</p> <p>These sort of emergency closures are often problematic as clearly, they are not planned, and in this case, it wasn't immediately obvious what was causing the damage to the highway.</p> <p>Residents are reminded that the best (and easiest) way to report issues such as this (and many more including missed bin collections) to Wiltshire Council is via the MyWilts app or online at <a href="#">MyWilts online reporting - Wiltshire Council</a>.</p> <p><b>School Travel Plan</b> No further update has been received from the school</p>

2022/204 Matters Arising Not Already on the Agenda	<p><b>Damaged Stile in Row Lane</b> The Chairman had not managed to contact the landowner as he lives away from Seend. The Seend Footpath Working group have offered to make the stile sturdier so making it less dangerous for users. In addition, they can make the gap smaller so animals can't get through. The Chairman suggested they go ahead with the works and he will liaise with landowner on his return. Anita Heatley to request the FWG proceed with the repair.</p> <p>A parishioner has suggested the stile be replaced with a 'Kissing Gate'. Phil Springate to forward a copy of the email to the Chairman to see if the Landowner would be willing to have the stile replaced. The cost of the replacement would be covered by The Parish Council / Wiltshire Council.</p> <p><b>Bradley Lane</b> Highways agreed to visit Bradley Lane and advise the best approach to be taken for a potential surface upgrade. Concern has been raised by parishioners that upgrading the lane's surface may result in cyclists travelling quicker along this route making it less safe for pedestrians. In previous minutes the Parish Council referred to the route as a cycleway and wishes it to be made known that the upgrade would be for a 'hard surface' that can be used by pedestrians, cyclists and horse riders. Before any such upgrade takes place, the Parish Council will arrange a village consultation.</p> <p><b>Dog Waste Bins</b> Wiltshire Council has advised they no longer provide or empty new dog waste bins deployed within the parish.</p>	Phil Springate / Chairman



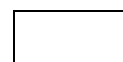

2022/206 Local Highways & Footpath Infrastructure Group (LHFIG)	<p><b>Local Highways &amp; Footpath Infrastructure Group (LHFIG)</b> The next LHFIG meeting is scheduled for 17<sup>th</sup> January 2023 at 1000 (via 'Teams'). The infrastructure improvement request for The Bell Crossroads and Bollands Hill will be an agenda item. The Clerk to attend.</p> <p><b>Bollands Hill</b> Due to the closure of Bollands Hill, Pelch Lane was used as a diversion. This has left the lane in a muddy and potentially dangerous state. The Clerk has obtained a priority road sweep of Pelch Lane and Highways are aware that the diversion signage placed on these works required some improvements. This matter has been raised with Wessex Water via the 'Streetworks' team.</p> <p>As a result of the broken Sewer pipe on Bollands Hill, The Clerk has written to Wessex Water to establish the cause of the break.</p> <p><b>Rusty Lane</b> Work to repair the surface of the lane is being undertaken by Wiltshire Council. Councillors raised concern about the stability of the new surface. The Clerk to write to Wiltshire Council.</p> <p><b>Metro Count A365</b> Highways confirmed the metro count deployed between Redstocks and the Turnpike Garage is for their Transport Planning team as part of ongoing monitoring of traffic flow within the county. The Clerk to request a copy of the results.</p> <p><b>School Grounds</b> A letter from the Chairman of FoSS was discussed by the Parish Councillors and a reply proposed. The Clerk to provide a draft reply for review by Councillors.</p> <p><b>A365 Broad Lane – Seend Fork</b> The gullies along this stretch of road have become blocked with debris and require clearing. 2022/216 Items for Note	<p><b>CLT Works</b> Contractors have been parking their vehicles on Seend Cleeve and undertaking construction work during periods when no on-site activity should be undertaken. Both items are a contravention of the planning consent issued. The chairman contacted CLT and received an apology for the infringement. In mitigation, CLT explained they found it necessary to restrict on-site parking in order to get large vehicles in to and unload materials, such as the large quantity of scaffolding. The parking situation is expected to improve as materials are used and surplus soil is removed from site. Wet weather and high wind delays impacted work and the site had to be left in a safe condition. Regrettably, working hours were extended in this instance.</p> <p><b>Car Parking adjacent to the Bridge at The Barge Inn</b> It was noted that an increased number of vehicles have been parking in this area – some appear to have been left overnight. It was suggested that photos should be taken if action is needed.</p> <p><b>Traffic Volume in the High Street</b> It has been reported that there has been a perceived increase in traffic volume through the village. However, it was noted recent local events such as the Lantern Parade in Devizes and sudden closure of Bollands Hill may have contributed to this.</p> <p><b>Bradley Lane bench &amp; Fence</b> The Gardening Cub bench appears to require some TLC along with the adjacent fence. Anita Heatley to check ownership of the fence with a view to facilitating repairs.</p>	Anita Heatley
